**NOTE:** The bylaws of the Illinois Credit Union League provide that each credit union that has paid its dues in accordance with the provision of Article V (5) of the bylaws is entitled to be represented at any meeting of the League by one delegate or an alternate delegate in the absence of the delegate, who must be a member of your credit union and who shall be entitled to one vote, and also provide that prior to the said meeting, each credit union shall file with the Secretary-Treasurer, in writing, the name and address of the delegate accredited thereto.

## CONVENTION REGISTRATION INSTRUCTIONS

Registration for the Illinois Credit Union League's Annual Convention is open ONLY to affiliated credit union volunteers and staff. Competitors of exhibitors are not permitted to register for the convention or enter the exhibit hall unless they register as exhibitors and pay the appropriate fees. Convention management reserves the right to refuse ineligible registrations.

REGISTRATION DEADLINE: MARCH 16, 2007 (OR FEBRUARY 16, 2007, FOR REDUCED RATE)

**1. DELEGATE:** The ONE official from each credit union who will cast the vote of the credit union at the annual meeting, Thursday, April 26 at 2:30 p.m. Place the delegate's name and title on the Convention Registration Form and mark the box for the Official Delegate. Delegates must complete the Official Delegate Registration Form above in addition to the Convention Registration Form. If the official delegate plans to attend only the Thursday annual meeting (no education sessions, reception, or exhibit hall), please check the Delegate Meeting Only box.

**2. ALTERNATE DELEGATE:** The ONE official from each credit union designated to take the place of the official delegate and cast the credit union's vote in the event that the official delegate is unable to attend. Place the Alternate Delegate's name and title on the registration form and check off the box for the Alternate Delegate. Also include the Alternate Delegate's name on the Official Delegate Registration Form.

**3. ATTENDEE:** All other board members, managers, or staff attending from your credit union. List names and titles on the registration form and check the box for Attendee.

**4. SPOUSE/GUEST:** Spouse/guest who do NOT serve on a credit union board or who are NOT employed by a credit union may register for this category. Spouse/guest who are attending as credit union employees or board members must be registered as attendees. Registered spouse/guest will be admitted to the exhibit hall, selected educational sessions, reception and receive a badge along with registration materials.

**5. REGISTRATION FEES:** Attendees, delegates and alternate delegates — \$215 per person; spouse/guests — \$95 per person prior to 2/16/07; \$225 and \$95 respectively after 2/16/07. Your paid registration fee includes registration materials, all education sessions, handout materials, admission to the exhibit hall, the Chairman's reception and the hospitality suite. **Delegates attending delegate meeting only — no charge.**

**6. TICKETS FOR SPECIAL EVENTS:** Determine the events to be attended by each person and check the appropriate boxes listed for events on Thursday and Friday. All ticket orders are non-refundable. **No refunds or exchanges at any time.** Orders must be received by March 16, 2007.

**7. PAYMENT:** All registration forms must be accompanied by the appropriate payment. Registration will NOT be processed until payment is received. Please total all charges for registration and special event fees. Make your share draft payable to the Illinois Credit Union League or debit your Members United Corporate FCU account or other corporate credit union account by completing and signing the authorization form.

**8. CONFIRMATION:** Please make copies of the registration form for your records. Your copy will be your only receipt. No confirmation letters will be sent.

**9. MAIL:** Mail the Convention Registration Form, the Official Delegate Form and payment to: Illinois Credit Union League, 77th Annual Convention, Attn: Education Department, P. O. Box 3107, Naperville, IL 60566-7107. **Deadline for convention registration is March 16, 2007.**

**10. CANCELLATION POLICY:** No charge for substitutions. Substitutions made after March 31, 2007 will be made only at convention registration at the hotel. Refunds, minus a \$50 cancellation fee will be made ONLY if the cancellation is received in writing and postmarked or faxed to the Illinois Credit Union League **no later than March 20, 2007.** All tickets to special events are non-refundable — no refunds or exchanges made at any time.

**11. SPECIAL NEEDS:** Do you have any special needs, i.e., physical, dietary, etc. that we can address to make your participation more enjoyable and meaningful? Please complete the appropriate space on the registration form or contact Education Department at 800/942-7124 x 3417.
